## Re: Freedom of Information Request FOI-000215-2020 Request Granted

*Dear*

I refer to your request, dated and received on 23<sup>rd</sup> June, 2020 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Your request sought:

*Under the Freedom of Information Act 2014, I request information pertaining to Garda Superintendents (District Officers) stationed at District Offices in Louth, Meath, Westmeath, Cavan and Monaghan between 2010 and 2020.*

*In full, I request details of every Garda Superintendent acting as officer in charge of District HQs stationed in Louth, Meath, Westmeath, Cavan and Monaghan between January 2010 and June 2020; the district offices/stations each Supt was based out of; and the length of each of their respective tenures (e.g Mar 2011 to Nov 2013).*

I wish to inform you that I have decided to grant your request on the 16<sup>th</sup> July, 2020.

The purpose of this letter is to explain my decision.

## 1. Findings, particulars and reasons for decision.

Upon receipt your request was forwarded to the Human Resource Section of An Garda Síochána who supplied the requested records. The table attached details the names, the districts and the term in which the Superintendents served in the districts.

## 2. Right of Appeal
