- statistics around recruitment and subsequent resignation by student and probationary gardaí in the years from 2018 up to and including 2022.
- The length of duration of service of new entrants from their arrival in Templemore to their resignation during the years 2018 up to and including October 2022.
- The reasons given for the resignation of student gardaí and probationary gardaí during the years 2018 up to and including October 2022.
- The age and gender of those students and probationary gardaí who have resigned during the years 2018 up to and including October 2022.

Clarified Request:

I can clarify as:

The goal of the first question is to seek a breakdown on statistics on how many student gardaí and probationary gardaí were recruited and then resigned in the allotted years.

This then also runs in tandem with the following elements:

- The length of duration of service of new entrants from their arrival in Templemore to their resignation during the years 2018 up to and including October 2022.
- The reasons given for the resignation of student gardaí and probationary gardaí during the years 2018 up to and including October 2022.
- The age and gender of those students and probationary gardaí who have resigned during the years 2018 up to and including October 2022.

I wish to inform you that I have decided to grant your request on the 9th November, 2022.
