Re: Freedom of Information Request FOI-000025-2022 Decision Granted

Dear

I refer to your request, dated and received on 10th January, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- 1) The number of Gardai by rank that retired from the force in the years of 2019, 2020 and 2021 in tabular form*
- 2) As of 7 January 2022 The number of Gardai that have applied to retire from the force between 10 January 2022 and 30 April 2022 in tabular form*

I wish to inform you that I have decided to grant your request on 2nd February, 2022.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant sections of An Garda Síochána where a search was conducted in respect of same. The table below outlines the number of Garda members by rank who have retired in 2019, 2020 and 2021, or submitted their application to retire or have retired in 2022 as of the 13th January, 2022. These figures include Voluntary Retirements, Compulsory Retirements, Cost Neutral Early Retirements.
