Dear

I refer to your request, dated 22nd February, 2022 and received on 23rd February, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the FOI Act, I am seeking the following:

:: All records relating to members of AGS who worked beyond the age of 60, over the past three years, to include the rank of the members, and the reasons for them working beyond 60.

I wish to inform you that I have decided to grant your request on 3rd March, 2022. The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt your request was forwarded to the relevant section of An Garda Síochána who conducted a search for records relating to your request.

The table below details Garda members by rank whose compulsory retirement date was extended over the past three years. These applications were processed under the Application to Extend Compulsory Retirement Date Due to the Outbreak of COVID-19 Programme and
