Dear

I refer to your request, dated and received on 27th June, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the Freedom of Information Act 2014;

1) I would like to request information on all Garda fines/fixed charge notices paid between 1 June 2021 and 27 June 2022, for the area under the Clontarf Garda Station, to include a breakdown by offence type - ie speeding, etc

2) I would like to request information on all Garda fines/fixed charge notices paid between 1 June 2021 and 27 June 2022, for the area under the Coolock Garda Station, to include a breakdown by offence type - ie speeding, etc

3) 2) I would like to request information on all Garda fines/fixed charge notices paid between 1 June 2021 and 27 June 2022, for the area under the Malahide Garda Station, to include a breakdown by offence type - ie speeding, etc

I would like this data in tabular form in a digital format such as a PDF or excel document. I am requesting that the data for each area be on its table. i.e. the data for the area under the Coolock Garda Station is one table.

I wish to inform you that I have decided to grant your request on 20th July 2022.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt your request was forwarded to the relevant Sections of An Garda Síochána who have provided the attached 3 appendices which details the records sought for Clontarf, Coolock and Malahide Garda Stations.

2. Right of Appeal

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
