## Re: Freedom of Information Request FOI-000374-2020 Request Granted

*Dear*

I refer to your request, dated and received on 15<sup>th</sup> October, 2020 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

*Please can I be provided with the following information:*

- 1. The number of official complaints made by both male and female garda employees in Donegal Garda Division relating to sexual harassment from January 2019 to this year to date;*
- 2. The nature of these complaints;*
- 3. The outcome of these complaints*

I wish to inform you that I have decided to grant your request on 27<sup>th</sup> October, 2020.

The purpose of this letter is to explain that decision.

### **1. Findings, particulars and reasons for decision**

Upon receipt, your request was forwarded to the Human Resource Management (HRM) Section of An Garda Síochána. HRM have provided records to this Office in response to your request.

I have been advised that the number complaints made by Garda employees in the Donegal Division relating to sexual harassment in 2019 and to date in 2020 is NIL.

## 2. Right of Appeal

The making of a late appeal may be permitted in appropriate circumstances.
