Dear

I refer to your request, dated 18th October, 2011 and received on 25th October, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

(Under the Freedom of Information Act 2014) Under section 7 of this act I would like to access the records held by An Garda Síochána. This information I am seeking relates to the road traffic enforcement fines revenue relating to Clovers Lane and to the entrance of Clovers Lane when entering from College Street in Killarney, County Kerry(Double yellow lines). I am seeking the monthly monetary amount of all fixed charge notices issued by An Garda Síochána on dates between 1.1.2020 - 18.10.2022 broken down by offence group if possible.

I wish to inform you that I have decided to grant your request on the 16th November, 2022.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Upon receipt, your request was forwarded to the relevant sections within An Garda Síochána to retrieve the information requested by you and a number of records have been identified.

The appendices attached detail the breakdown of the monthly monetary amount of all fixed charge notices issued by An Garda Síochána broken down by offence group issued for Clovers Lane and College Street in Killarney for the years 2020, 2021 and 2022 (September).

2. Right of Appeal


