Dear ,

I refer to your request, dated and received on 18th November, 2021 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the Freedom Of Information Act 2014, I am seeking the following:

- *The number of Gardaí currently assigned to the Mayo Garda Division.*
- *The number of Gardaí currently assigned to each station in the Mayo Garda Division by rank*
- *The number of Gardaí who have left their post for any reason in the Mayo Division since 2019*
- *The number of Gardaí newly assigned or reassigned to the Mayo Division since 2019.*

I would like to receive this information electronically, preferably in its original formatting.

I wish to inform you that I have decided to grant your request on the 30th November, 2021.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant sections of An Garda Síochána where searches were conducted in respect of same. The table below details the records sought in part 1 and 2 of your request.

Regarding part 3 and 4 of your request I can advise you that 63 members left the Mayo Division from 2019 to date. Out of those 63 members, 44 were transferred, 16 members retired and there were 3 members that passed away. A total of 50 members were assigned to the Division in the same period. 33 members were transferred in, there were 15 newly attested members from the College and 2 members were reassigned to the Mayo Division.

The making of a late appeal may be permitted in appropriate circumstances.
