## Re: Freedom of Information Request FOI-000009-2015 Request Refusal

Dear

I refer to the Freedom of Information Act 2014 and your submission to this body dated 14/10/2015 and received on 14/10/2015.

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency *"insofar as it relates to administrative records relating to human resources, or finance or procurement matters"*. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

*"I wish to request, under the Freedom of Information Act, details of the number of complaints made against gardai relating to race / racism since 2013."*

I, \_\_\_\_\_ wish to inform you that your request has been refused.

The purpose of this letter is to explain my decision.

### 1. Findings, particulars and reasons for decision

I am refusing your request on the basis that the records are not readily identifiable and it would cause a substantial and unreasonable disruption in Human Resources and People Development of An Garda Síochána to inspect all manual records held to identify this particular type of behaviour.

Section 15(1)(c) of the Freedom of Information Act 2014 is as follows:

15. (1) A head to whom an FOI request is made may refuse to grant the request where—

*(c) in the opinion of the head, granting the request would, by reason of the number or nature of the records concerned or the nature of the information concerned, require the retrieval and examination of such number of records or an examination of such kind of the records concerned as to cause a substantial and unreasonable interference with or disruption of work (including disruption of work in a particular functional area) of the FOI body concerned,*

With reference to your request I wish to make you aware that complaints received by An Garda Síochána from a member of the public against a member of the Garda organisation are forwarded to the Garda Síochána Ombudsman Commission (GSOC) for their investigation and deliberation as they deem necessary. The public can also make a complaint directly to GSOC without informing An Garda Síochána. As a result the Human Resources and People Development section of An Garda Síochána will not have a comprehensive list of all complaints made against Garda members. The complaints received, for onward transmission to GSOC, are not categorised by the Gardai receiving them as the investigation by GSOC will determine if the complaint is valid and the type of incident that occurred e.g. racist.

In accordance with the requirements of section 15(1)(c) of the Freedom of Information Act 2014 I am refusing your request.
