I refer to the Freedom of Information Act 2014 and my correspondence to you of 15th October 2015 and to your submissions to this body, received on 15th October 2015.

I refer to the request which you made under the Freedom of Information Act 2014 for records held by An Garda Síochána:

How many sick days have been registered by members of An Garda Síochána in the years 2011/12/13/14?

What is the estimated cost of these sick days?

How many members of An Garda Síochána have been injured in the line of duty in the same time frame?

What was the nature of these injuries?

How long were members left out of work as a result?

I, _____ wish to inform you that your request **has been granted**.

1. Findings, particulars and reasons for decisions

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency “insofar as it relates to administrative records relating to human resources, or finance or procurement matters”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

The table below sets out the number of days lost due to illness by members of An Garda Síochána in the years 2011 – 2014.

It also includes the total cost for sick leave and the total number of days recorded as an Occupational Injury/Illness arising from Duty in the years 2011 – 2014. These figures do not account for members who were injured in the course of duty but did not avail of sick leave.

Total No. of Sick Days recorded on SAMS (Sickness Absence Management System), are the number of calendar days that staff are absent, including those members who are absent due to being injured on duty and may also include weekends and rest days.
