Re: Freedom of Information Request FOI-000082-2015 Request Refusal

Dear

I refer to the Freedom of Information Act 2014 and your submission to An Garda Síochána dated 20/10/2015 and received on 20/10/2015.

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency *"insofar as it relates to administrative records relating to human resources, or finance or procurement matters"*. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

" - Copies of all internal reports into alleged misconduct/breach of garda protocol by members of An Garda Síochána.

This request includes copies of reports carried out into allegation of misconduct against garda officers.

This request also includes the action, if any, taken against officers when misconduct was established.

The time frame for this request is 01/01/13-today's date."

I, _____ wish to inform you that your request has been refused.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

I am refusing your request on the basis that it would cause a substantial and unreasonable disruption in Human Resources and People Development of An Garda Síochána to inspect all manual records held to provide the information sought.

Section 15(1)(c) of the Freedom of Information Act 2014 is as follows:

15. (1) *A head to whom an FOI request is made may refuse to grant the request where—*
- (c) *in the opinion of the head, granting the request would, by reason of the number or nature of the records concerned or the nature of the information concerned, require the retrieval and examination of such number of records or an examination of such kind of the records concerned as to cause a substantial and unreasonable interference with or disruption of work (including disruption of work in a particular functional area) of the FOI body concerned,*

With reference to your request I wish to make you aware that there were 1,197 files opened by the Complaints Section of An Garda Síochána in 2013 and a further 1,323 in 2014. Information regarding the number of complaints received and dealt with by the Complaints Section and Discipline Section is available on the Garda Website at www.garda.ie. Similarly information regarding complaints made against members of An Garda Síochána may be available from the Garda Síochána Ombudsman Commission who can receive complaints directly from members of the public.

In accordance with the requirements of section 15(1)(c) of the Freedom of Information Act 2014, I am refusing your request.

2. Right of appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number **F01-000082-2015**.

The making of a late appeal may be permitted in appropriate circumstances.
