## Re: Freedom of Information Request FOI-000151-2015 Part-Granted

Dear

I refer to the Freedom of Information Act 2014 and your submission to An Garda Síochána dated 15<sup>th</sup> November 2015 and received on 15<sup>th</sup> November 2015.

I refer to the request which you made under the Freedom of Information Act 2014 for records held by An Garda Síochána:

- '-For information of the total number of working days Gardaí stationed in Co Roscommon were absent from work due to suspension in (a) - 2013, (b) 2014 and (c) so far in 2015:*
- For information on the total number of Gardaí stationed in Co Roscommon who the above suspensions related to in each of the above years.*
- For information on the total number of working day Gardaí stationed in Co Roscommon were absent from work due to illness, occupational injury or suspension in (a) 2013, (b)2014 + (c) so far in 2015. Please provide a breakdown in each case.*
- For information on the total number of Gardaí stationed in Co Roscommon who were absent from work on sick leave for (a)more than ten days and (b) more than 28 days in (a) 2013, (b)2014 + (c) so far in 2015.*
- For information on the total number of working days Gardaí stationed in Co Roscommon were absent from work due to occupational injury in (a) 2013, (b)2014 + (c) so far in 2015, along with the total number of Gardai stationed in Co Roscommon who were absent from work due to occupational injury in (a) 2013, (b)2014 + (c) so far in 2015.*

*In the event of the above statistics are not available solely in Co Roscommon, I would like the same information for Longford Roscommon Garda District.*

*I would also like to request information on the total number of Gardaí currently stationed in Co Roscommon.'*

I wish to inform you that your request has been **part-granted**.

The purpose of this letter is to explain that decision.

**1. Findings, particulars and reasons for decision**

**Suspension**

The first part of your request relates to suspension and you sought:

*'-For information of the total number of working days Gardai stationed in Co Roscommon were absent from work due to suspension in (a) - 2013, (b) 2014 and (c) so far in 2015:*

*-For information on the total number of Gardai stationed in Co Roscommon who the above suspensions related to in each of the above years.*

In reply to your query, I am refusing to grant your request seeking the number of working days Gardai stationed in Co. Roscommon who were absent and the total number of Gardai stationed in Co. Roscommon who the suspensions relate to. Section 37(1) of the Freedom of Information Act 2014 states

*'Subject to this section, a head shall refuse to grant an FOI request if, in the opinion of the head, access to the record concerned would involve the disclosure of personal information'*

An Garda Síochána operates on a Divisional basis and therefore the information is provided accordingly. However, by releasing the information in respect of suspensions on a County or indeed a Divisional basis may unintentionally lead to the identification of the individuals who may be involved. This is due to the minority of member's of the organisation who have been suspended in the previous 3 years.

I am, however, in a position to provide you with the national figures for the number of days lost due to suspension and the number of members of An Garda Síochána who were suspended in the years 2013, 2014 and from 1<sup>st</sup> January to 7<sup>th</sup> November 2015. These are set out in the tables below.
