#### Dear

I refer to the Freedom of Information Act 2014 and your submission to An Garda Síochána, dated and received on the 23rd February 2016.

Part 1 (n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

The number of instances where Garda vehicles were damaged and had to be replaced in 2014 and 2015.

- The total cost of these replacements and a breakdown where possible

I have now made a final decision to grant your request.

The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decisions to deny access

The Garda Transport Section manages a fleet of approximately 2,600 vehicles distributed throughout Garda Divisions and specialist units. The fleet consists of marked and unmarked patrol cars, motorbikes for high visibility roads policing and vans for public order policing.

Garda vehicles cover a significant amount of kilometres per annum and are involved in a wide range of policing activities such as patrols, monitoring traffic, escort duties and community based activities.

In 2014, 21 vehicles were deemed beyond repair following collisions, as were 31 vehicles in 2015. I advise that in such cases vehicles are not normally replaced directly as all new vehicles are purchased from the available budget in any year and are allocated on a prioritised basis.

It is the responsibility of each Divisional Officer to allocate Garda vehicles efficiently within their Division as operational demands dictate.
