Re: Freedom of Information Request FOI-000098-2017 Request Refused.

Dear Mr Foxe,

I refer to your request, dated and received on 6th March, 2017 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- Copies of the tender notice and/or contract regarding provision of PR services by Communications Clinic to An Garda Siochana.
- Copies of any emails between the Garda Commissioner Noirín O'Sullivan and PR consultant Terry Prone or the Communications Clinic during the period in which those services were provided to AGS.

I wish to inform you that I have decided to refuse your request on the 4th April, 2017.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decisions.

An Garda Síochána awarded a contract, after a public procurement competition, to The Communications Clinic in respect of *Media Training for Personnel in An Garda Síochána* and the contract was signed on the 30th September 2015. The media training programme for Senior Officers and Managers enables An Garda Síochána to provide more spokespeople to the media in order to keep the public informed about how An

Garda Síochána prevents and tackles crime. Under this training programme over 100 senior officers and managers have received media training. This has also seen The Communications Clinic provide advice on communication initiatives.

I advise that I am <u>refusing</u> the first of your request seeking records in relation to the tender notification and contracts with the Communications Clinic pursuant to section 15(1)(i) which states:

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where -
 - (i). the request relates to records already released, either to the same or a previous requester where
 - (i) the records are available to the requestor concerned

I advise that these records were subject to a previous Freedom of Information request (FOI-000180-2016). An Garda Síochána publishes all decisions made on requests for non-personal information, including the full decision letter, on its website. With regard the second part of your request seeking "Copies of any emails between the Garda Commissioner Noirín O'Sullivan and PR consultant Terry Prone or the Communications Clinic..."

Your request was forwarded to the Office of the Commissioner on receipt to carry out searches for all emails between the Garda Commissioner, PR Consultant, Ms. Terry Prone and The Communications Clinic. The period the search was carried out for was between the 30th September 2015 and the 4th April 2017. The following email addresses were searched noirinos@gmail.com, Commissioners's office email, and noirinos@gmail.com, Resources; funding; expenditure; request for tender; RFT; OGP; staff; personnel; recruitment and members. I advise that no records were found.

I am therefore <u>refusing</u> this part of your request subject to section 15(1)(a) of the FOI Act.

Refusal on administrative grounds to grant FOI requests

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where—
 - (a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,

2. Right of appeal

The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
