Request Refusal

Dear

I refer to the Freedom of Information Act 2014 (FOI Act) and your submission to this body dated and received on the 26th February 2016 for records held by An Garda Síochána.

Part 1 (n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

"I request a copy of the following documents (or documents containing the following information) to be provided to me: The total cost per year allocated for Gardaí to monitor CCTV in Limerick County in the years 2011 to 2015"

I wish to inform you that your request has been refused.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

I am refusing your request on the basis that the records you seek do not exist. The monitoring of CCTV is not performed by An Garda Síochána across the County of Limerick.

Section 15(1)(a) of the FOI Act 2014 is as follows:

Refusal on administrative grounds to grant FOI requests

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where—
 - (a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,
