I refer to the Freedom of Information Act 2014 and your submission to this body dated 23rd November, 2016 and received on 24th November, 2016 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

"The cost of using the Garda helicopter or air support in 2011, 2012, 2013, 2014, 2015 and 2016 to date"

I have now made a final decision to grant your request on 6th December, 2016.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decisions.

A search was conducted via the Finance Section for the information you sought in the FOI request. The figures provided below show the costs associated with the maintenance of the two helicopters which is born by the Garda Vote. The maintenance of the Garda helicopters is outsourced. The figures provided for 2016 are up to and including October 2016.

The Garda Air Support Unit, which is part of the Operational Support Services, was established in September 1997. The Unit is based at Casement Aerodrome, Baldonnel on the outskirts of Dublin city although from time to time aircraft may be based at other locations within the State.

Garda aircraft may be deployed to a variety of incidents such as where there is an immediate threat to life, incidents of a criminal, terrorist or other nationally important nature, immediate threat of serious public disorder, evidence gathering and photographic tasks.
