### Re: Freedom of Information Request FOI-000078-2016 Granted

#### Dear

I refer to the Freedom of Information Act 2014 and your submissions to An Garda Síochána dated 24 dated and received on 24th February 2016.

Part 1(n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

- 1. How much income was generated from fines relating to parking in disabled parking bays in county Mayo in the years 2013,2014, and 2015?
- 2. Where was the income generated from fines for parking in disabled parking bays in county Mayo in 2013,2014, and 2015 spent?

I, Helen Deely, Superintendent wish to inform you that your request is granted.

The purpose of this letter is to explain that decision.

# 1. Findings, particulars and reasons for decisions to deny access

A search was conducted in our Finance Directorate who have provided information in respect of your request.

Part 1 of your request sought 'How much income was generated from fines relating to parking in disabled parking bays in county Mayo in the years 2013, 2014 and 2015?'

The figures provided below relate to incidents available on the Fixed Charged Processing System on 2<sup>nd</sup> March 2016.

Year	Fee payable €	Incidents
2013	3,480	42
2014	3,240	39
2015	1,600	19

It should be noted that the 2015 figures may not be complete due to time delays in receiving and processing notices from members. Equally not all offences from November/December 2015 will have reached the 'due by payment' date. Those not paid, go to summonses and are a matter for the Courts Service thereafter.

The 'fees payable' figures provided above relates to the total level of fees that would be received if the fines were paid in full.

Please also be advised that Traffic Wardens employed by local County/Town Councils have the power to issue Fixed Charge Notices in respect of parking offences which are not related in any way to the Garda Síochána Fixed Charged Processing System.

Part 2 of your request sought 'where was the income generated from fines for parking in disabled parking bays in county Mayo in 2013, 2014, and 2015 spent?'

Section 15(1)(a) of the Freedom of Information Act 2014 states that:

A head to whom an FOI Request is made may refuse to grant the request where-

(a) The record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken.

I am to inform you that there are no records available in this regard. However, I can advise you that on receipt of the fees generated from the Fixed Charged Processing System, they are allocated as follows:

- Returned to the Exchequer as 'Extra Exchequer Receipts'
- Allocated as 'Appropriations-in-Aid' in the Appropriation Accounts of Vote 20 An Garda Síochána

### 2. Right of appeal

The making of a late appeal may be permitted in appropriate circumstances.
