I refer to your request, dated and received on 19th February, 2025 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the Freedom of Information Act 2014, I am requesting the following records: -

1. The total amount spent on Garda rank overtime in each of the calendar years 2016 to 2024 inclusive.

While annual overtime data is published for the total Garda workforce, this request is for annual data relating to Gardai at Garda rank only.

2. The average number of Gardai at Garda rank in An Garda Siochana across each of the calendar years 2016 to 2024 inclusive.

I wish to advise that I have made a decision to part-grant your request on the 18th March, 2025. The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

On receipt your request was forwarded to the Finance Section of An Garda Síochaná who conducted a search for records relating to your request. The table below contains the records sought in part 1 of your request.
