I refer to the Freedom of Information Act 2014 (FOI Act) and your submission to this body, dated and received on 26th April 2016.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- 1) Copies of the results of all public attitude surveys conducted on behalf of an Garda Siochana in 2015 and 2016 to date.
- 2) The amount spent by An Garda Siochana on public attitude surveys in 2015 and 2016 to date, and the company or companies who received the payments.

I wish to inform you that your request has been partially granted on today's date.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

I refer to the first part of your request in which you seek 'copies of the results of all public attitude surveys conducted on behalf of An Garda Síochána in 2015 and 2016 to date'. I wish to inform you that Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

The Public Attitudes Survey examines people's opinion on crime and policing related matters. In this respect, I am refusing this part of your request as it falls outside the scope of the Act insofar as it pertains to An Garda Síochána.

In relation to the second part of your request in which you seek 'the amount spent by An Garda Siochána on public attitude surveys in 2015 and 2016 to date, and the company or companies who received the payments.'

The objective in undertaking the procurement exercise for the Garda Síochána Public Attitudes Survey was to procure the services of a company that would provide a top quality survey of public attitudes relating to satisfaction, victimisation, views on crime, and views on Garda service and how it can be improved. The Public Attitudes Survey was procured following a public tender competition that received a high number of responses from both Ireland and the UK. It involves interviewing 1,500 people per quarter on key areas of the organisation. It provides An Garda Síochána with high quality information that has been used to help the organisation to enhance the service it provides to the public.

Please see table below which outlines the expenditure in relation to the Garda Síochána Public Attitudes Survey from 1st January 2015 – 30th April 2016.
