Dear Mr. D'Arcy,

I refer to your request, dated and received on the 3rd May 2017, which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered

Your request sought:

A breakdown of gardaí of all ranks in each Garda division nationwide under the following headings: average age; gender; country of birth. The information requested should ideally be provided in tabular digital format under each of the aforementioned headings for each division.

I wish to inform you that I have decided to part-grant your request on the 29th May, 2017.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

With regard to your request, I am to advise you that a search was conducted in the Human Resource Management Section of An Garda Síochána in respect of same and I now attach the

requested information outlining the average age and gender of Garda members in each of the 29 operational Garda Divisions nationwide as of 31st March 2017.

The sections of the FOI Act which may deny access to information are known as exemptions.

Section 15(1) of the Freedom of Information Act states:-

15(1) A head to whom an FOI request is made may refuse to grant the request where –

The record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken

Information in relation to the country of birth of members of An Garda Síochána is not recorded therefore I am refusing this aspect of your request under section 15(1)(a) as outlined above.

2. Right of Appeal

The making of a late appeal may be permitted in appropriate circumstances.
