Dear Mr. Dunne,

I refer to your request, dated the 9th July 2017 and received on the 10th July 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- 1. Records of the number of days lost due to ordinary illness and the number of days lost due to injury on duty by members of An Garda Siochána for the years 2015 and 2016 broken down by the operation Garda Divisions
- 2. Records of the numbers of sworn members who availed of sick leave over the same period

I wish to inform you that I have decided to grant your request on the 2nd August 2017.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Following a search of records within the Human Resource and People Management Directorate, a number of records have been identified in respect of your request.

Part 1 of your request sought 'records of the number of days lost due to ordinary illness and the number of days lost due to injury on duty by members of An Garda Síochána for the years 2015 and 2016 broken down by the operation Garda Divisions'

Please see Appendix A and B attached which outlines the number of days lost due to ordinary illness and the number of days lost due to injury on duty by members of An Garda Síochána for the years 2015 and 2016 broken down by the Operational Garda Divisions.

It should be noted the total number of Sick Days recorded on SAMS (Sickness Absence Management System) are the number of calendar days that sworn members are absent, including those who are absent due to being injured on duty and may also include weekends and rest days.

Part 2 of your request sought 'records of the numbers of sworn members who availed of sick leave over the same period'

Members of An Garda Síochána who avail of sick leave of more than one day absence are required to provide a medical certificate from their GP.

The new Public Service Sick Leave Scheme was introduced from 31st March 2014. The Public Service Management (Sick Leave) Regulations 2014, made by the Minister for Public Expenditure and Reform set out the terms of the new Public Service Sick Scheme.

The rationale for the new scheme is to increase productivity, and lower the cost of sick leave by reducing the periods during which paid sick leave will be available and capping the period during which "temporary rehabilitation remuneration", formerly "pension rate of pay", may be paid.

Under the terms of the new Public Service Sick Leave Scheme, entitlement to paid sick leave is now calculated over a rolling four year period for members of An Garda Siochána.

The table below sets out the total number of days lost due to illness by members of An Garda Síochána in 2015 and 2016 broken down by injury on duty and ordinary illness. Also included is the number of sworn members who availed of sick leave for the said years.
