Dear Mr. O'Rafferty,

I refer to your request, dated the 31st July 2017 and received on the 1st August 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I AM LOOKING FOR DATA RELATED TO THE DIVERSITY OF STAFF

AT AN GDARDA SÍOCHÁNA. THIS INCLUDES A PROFILE OF THE AGE,

GENDER & ETHNIC BACKGROUND OF SERVING GARDAI.

I wish to inform you that I have decided to part-grant your request on the 29th August 2017.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

With regard to your request, I am to advise you that a search was conducted in the Human Resource Management Section of An Garda Síochána in respect of same and I can now provide information in respect of the age and gender profile of An Garda Síochána.

The sections of the FOI Act which may deny access to information are known as exemptions.

In respect of information regarding the ethnic background of serving Gardaí, I am to advise you that this information is not centrally recorded and in order to retrieve the information would cause substantial disruption to the working of the division or section. Therefore, I am refusing your request under Section 15(1)(c) of the FOI Act.

Section 15(1) of the Freedom of Information Act states:-

- 15(1) A head to whom an FOI request is made may refuse to grant the request where
 - (c) In the opinion of the head, granting the request would, by reason of the number of nature of the records concerned or the nature of the information concerned, require the retrieval and examination of such number of records or an examination of such kind of the records concerned as to cause a substantial and unreasonable interference with or disruption or work (including disruption of work in a particular functional area) of the FOI body concerned.

2. Right of Appeal
