# Re: Freedom of Information Request FOI-000357-2017 Part Grant

#### Dear

I refer to your request, dated and received on 14<sup>th</sup> August, 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

How many full-time Garda officers are there stationed at each station in Donegal as of today, August 14 2017?

How many full-time officers were stationed in each station in Donegal in each of the last ten years?

Can I get this information in list format, ie broken down by each station individually.

I wish to inform you that I have decided to part grant your request on the 8th September 2017.

The purpose of this letter is to explain my decision.

## 1. Findings, particulars and reasons for decision

Details of your request were forwarded to the Human Resource Directorate of An Garda Síochána who conducted a search of their records for the information that you have requested.

A part of the core functions of An Garda Síochána is the operational necessity to meet public demands with regard to security and public safety. The allocation of resources within the confines of a Garda Division are proportionate to the requirements necessary to meet the core functions of An Garda Síochána in any given area within that Division.

The redistribution of staff within a Garda Division can be a gradual process as public needs dictate, for e.g. in response to changing crime trends and/or demographics. It can also be as a result of an immediate response to a significant change in security requirements. Extra resources will be sourced and allocated to a particular Garda Station(s) to provide for particular security needs. This type of resource allocation is made based on security risk assessments and as an operational requirement.

It should be noted that the allocation of Gardaí within a Division is determined by the Chief Superintendent of that Division who has the responsibility to ensure that the allocation is carried out appropriately and equitably.

The Sections of the FOI Act which deny access to information are known as exemptions.

I am refusing the first part of your request for 'How many full-time Garda officers are there stationed at each station in Donegal as of today, August 14 2017' including the staffing figures at each Garda Station for 2017 under Section 15(1)(f) of the FOI Act, on the basis that An Garda Síochána intends to publish the figures on the Garda Síochána website at www.garda.ie

#### Refusal on administrative grounds to grant FOI requests

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where—
  - (f) the FOI body intends to publish the record and such publication is intended to be effected not later than 6 weeks after the receipt of the request by the head,

In relation to the second part of your request I wish to advise that the Garda organisation is only subject to the provisions of the FOI Act 2014 and was not subject to the provisions of the FOI Act of 1997. As a result, the start date for the provision of records, excluding personal records, as set out in section 2(1) of the FOI Act for An Garda Síochána is 21<sup>st</sup> April 2008. This date is known as the *effective date* which is outlined below.

"effective date" means:

(c) in the case of an entity that immediately prior to enactment of this Act, was not a public body within the meaning of the Act of 1997, but is a public body within the meaning of this Act, 21 April 2008, unless provision is made to the contrary by order under section 6;

On that basis I am refusing to provide information for 2007 as sought by you in respect of your request seeking: 'How many full-time officers were stationed in each station in Donegal in each of the last ten years?' However, I am in a position to provide you with the staffing figures in respect of years 2008, 2009 and 2010. Please find a breakdown at Schedule A, B and C attached.

I wish to draw your attention to the staffing levels of An Garda Síochána (2011 to 2016), detailed to District level, which are available on the FOI Publication Scheme of the Garda website and can be accessed at the following link:

I am aware that the information in relation to staffing figures at each Garda Station for years 2011-2016 was the subject of an article in 'The Times' newspaper on 16<sup>th</sup> November 2016. You may access this article by following the link below where the figures for 2011-2016 are published:

On that basis, I am therefore refusing to release the staffing figures for years 2011 - 2016 under Section 15(1)(d) which states:

- 15(1) A head to whom an FOI request is made may refuse to grant the request where
  - (d) the information is already in the public domain.

#### 2. Right of Appeal

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
