Dear Ms. Bracken,

I refer to your request, dated and received on the 28th August 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

'I am seeking records on how much has been spent on cosmetics for garda commissioner Noirin O'Sullivan since she was appointed commissioner in 2014.

I am also seeking records how much was additionally spent on cosmetics for other garda members since 2014.

Also, if at all possible, a breakdown of what type of cosmetics have been purchased on behalf of the garda commissioner and/or other garda officers.'

I wish to inform you that I have decided to refuse your request on the 19th September 2017.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

On receipt of your request, a search was conducted in the Commissioner's Office and also in the Finance Directorate of An Garda Síochána.

Following a detailed search in both of the offices outlined above, I am to advise you that no records have been identified in respect of your request. I further advise that the former Garda Commissioner did not expend any public monies in the purchase of cosmetics during her tenure as Garda Commissioner, therefore no records exist. For the same reasons, it is also not possible to provide a breakdown of the type of cosmetics purchased. In this regard, I am refusing your request in accordance with Section 15(1)(a) of the Freedom of Information Act 2014 which states:

Refusal on administrative grounds to grant FOI requests

the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken

2. Right of Appeal

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
