Dear

I refer to your request, dated 2nd October, 2017 and received on 4th October, 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

A complete list of relatives of people killed on Irish roads over the last six(6) years. Would you please forward a complete list of those seriously injured, and injured on Irish roads over the last six(6) years. Please include phone contact numbers and postal addresses in all of the above mentioned cases.

I wish to inform you that I have decided to refuse your request on the 10th October, 2017.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a Public body for the purposes of the Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of

the Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term "administrative records" is understood to mean records relating to the processes of running and managing a business or organisation.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act.

The Data Protection Office within An Garda Síochána was also contacted to seek their views on the information sought by you. They have advised that you are not entitled to the information through Data Protection as An Garda Síochána cannot disclose personal data relating to another individual unless that other individual has consented to the disclosure. The Data Protection Office is not under any obligation to seek such consent.

2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number FOI-000437-2017.

The making of a late appeal may be permitted in appropriate circumstances.
