# Re: Freedom of Information Request FOI-000458-2017 Request Refused

#### Dear

I refer to your request, dated and received on 20<sup>th</sup> October, 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

• I am writing to you to request information under section 6 of the freedom of information act 2014. I am requesting information on the number of gardai that were dispatched to deal with incident on Monday the 16th of October during the time when there was a red weather warning in place due to hurricane Ophelia

I wish to inform you that I have decided to refuse your request on the 1st November, 2017.

The purpose of this letter is to explain my decision.

### 1. Findings, particulars and reasons for decision

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term "administrative records" is understood to mean records relating to the processes of running and managing a business or organisation. As a result, the FOI Act excludes operational policing business as opposed to the defined administrative processes of An Garda Síochána. Therefore, records relating to the manner in which Gardai were dispatched to deal with incidents relating to the hurricane 'Ophelia' are operational, not administrative, and are outside the scope of the FOI Act insofar as the Garda Síochána is concerned.

Consequently, I am refusing your request as it is falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the FOI Act.

#### 2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number FOI-000458-2017.

The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
