## Re: Freedom of Information Request FOI-000486-2017 Request Refused

*Dear*

I refer to your request, dated 28<sup>th</sup> October, 2017 and received on 31<sup>st</sup> October, 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency “insofar as it relates to administrative records relating to human resources, or finance or procurement matters”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

*I am looking to find out the official number of Anti-Social Behaviour Orders (ASBOs) that have been issued in the town of Drogheda, Co. Louth. In a perfect world, I would like to request a year-by-year breakdown, covering the last 4 years.*

*Alternatively, if this is too precise, I would equally accept the same request for the entire of Louth (ie; how many Anti Social Behaviour Orders have been issued in Co. Louth, as a whole).*

*I would prefer to find the stats for just Drogheda itself, however, or for ASBO's issued just by Drogheda Garda Station in the above time-frame.*

I wish to inform you that I have decided to refuse your request on the 1<sup>st</sup> November, 2017.

The purpose of this letter is to explain my decision.

## 1. Findings, particulars and reasons for decision

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term “administrative records” is understood to mean records relating to the processes of running and managing a business or organisation. As a result the FOI Act excludes operational policing business as opposed to the defined administrative processes of An Garda Síochána.

The records you sought relate to operational policing matters carried out by An Garda Síochána, as opposed to administrative matters relating to human resources, or finance or procurement.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act.

## 2. Right of Appeal

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
