## Re: Freedom of Information Request FOI-000012-2015

## Request Refusal

#### Dear

I.

I refer to the Freedom of Information Act 2014 and your submission to this body dated 21/10/2015 and received on 21/10/2015.

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

"Details of all staff working in Fermoy Garda Station on the day of September 12 and early morning September 13, 2015.

Details to include garda rank and shift hours worked.

Records should also indicate if any overtime was worked by any staff member and for the amount of overtime worked and, if available, a reason for this overtime."

wish to inform you that your request has been refused.

The purpose of this letter is to explain my decision.

## 1. Findings, particulars and reasons for decision

Your request is being refused under section 32(1)(a)(i) and 32(1)(a)(ii) of the Freedom of Information Act 2014 as I am of the opinion that this information can be reasonably expected, if used inappropriately, to prejudice or impair An Garda Síochána in Fermoy Sub District in:

- (i) "the prevention, detection or investigation of offences, the apprehension or prosecution of offenders or the effectiveness of lawful methods, systems, plans or procedures employed for the purposes of the matter aforesaid"
- (ii) "the enforcement of, compliance with or administration of any law"

The detail sought by you in your request of 14<sup>th</sup> October 2015 seeks to identify, in detail, the operational capabilities of An Garda Síochána in a specific location on a specific date and during a definite period of time. This type of information is not provided due to its operational sensitivity. The data sought will easily identify the staffing available within Fermoy Garda Station on a Saturday night into Sunday morning. This information, if made available, could reasonably be expected to pose a risk to the safety of local Gardaí when endeavoring to enforce legislation and keep the public peace in the future. If staffing levels were to be provided it is reasonable to believe that a criminal organisation could use this information to assess the capabilities of the local Gardaí to deal with certain types of crimes, thus prejudicing the Garda Organisations effectiveness in enforcing legislation. The duty roster system in use in An Garda Siochána is available in the public domain and cross referencing that system with the staffing levels available on the 12<sup>th</sup> & 13<sup>th</sup> September 2015 would allow for a prediction to be made as to the response capabilities of Fermoy Gardaí by a criminal organisation. This is an unnecessary risk to the law enforcement procedures employed in Fermoy and the staff of that station.
