### Re: Freedom of Information Request FOI-000022-2015 **Request Part-Granted**

#### Dear

I refer to the Freedom of Information Act 2014 and my correspondence to you of 14th October 2015 and to your submissions to this body, received on 14th October 2015.

I refer to the request which you made under the Freedom of Information Act 2014 for records held by An Garda Síochána:

'A list of all reports and investigations carried out by An Garda Síochána's internal audit unit since January, 1 2014.

Copies of any internal audits relating to the procurement of services within An Garda Síochána since January 1, 2013.'

I now wish to inform you that your request has been part-granted.

The purpose of this letter is to explain that decision.

#### 1. Findings, particulars and reasons for decisions

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

The sections of the Act which can apply to deny access to documents are known as its exemption provisions.

In respect of the first part of your request wherein you sought:

'A list of all reports and investigations carried out by An Garda Síochána's internal audit unit since January 1, 2014'

Please find attached herewith a list of all reports and investigations carried out by An Garda Síochána's Internal Audit unit since 1<sup>st</sup> January 2014. You will note that 23 audits were completed within the organisation in 2014.

In respect of the second part of your request, wherein you seek:

'Copies of any internal audits relating to the procurement of services within An Garda Síochána since January 1, 2013.'

I now wish to advise you that I am refusing this part of your request. Section 15(1)(f) of the Freedom of Information Act 2014 states:

- (1) "A head to whom an FOI request is made may refuse to grant the request where-"
  - (f) "the FOI body intends to publish the record and such publication is intended to be effected not later than 6 weeks after the receipt of the request by the head".

I understand a member of staff from this office has spoken to you with regard to this matter and has advised that two Internal Audit reports have been identified.

Your request is being refused under section 15(1)(f) of the Freedom of Information Act 2014, as An Garda Síochána intends to publish these reports on the Garda Síochána web site <a href="www.garda.ie">www.garda.ie</a> in the immediate future.

#### 2. Rights of appeal

The making of a late appeal may be permitted in appropriate circumstances.
