

Re: Freedom of Information Request FOI-000052-2016

Dear

I refer to your request, dated 07/02/2016 and received on 08/02/2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Siochána.

Your request sought:

I wish to receive information about all items which have been reported lost/missing or stolen within the Gardai since 2011.

This should include a description of each item, the date it was reported as missing/lost or stolen and its value.

If the item was subsequently found or recovered, details about this should also be included as well as information about who misplaced it and its location. Or if it remains missing, this should also be clarified.

Part 1 (n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a practically included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. As the records sought by you do not fall within the remit of the Freedom of Information Act 2014 insofar as it relate to An Garda Síochána you request is refused.

Right of appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number F01-000052-2016.

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
