I refer to the Freedom of Information Act 2014 (FOI Act) and your submission to this body received on the 16th February 2016.

Part 1 (n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

"All correspondences/letters/emails etc between the Commissioner/Commissioners Office and the GRA since September 1st 2015 to February 16th 2016."

I wish to inform you that your request has been refused.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision to deny access

I am satisfied that all correspondence in the office of the Garda Commissioner is held electronically. A search was conducted across the electronic correspondence recorded in the Commissioner's Office to identify records which had key words in the title such as "Garda Representative Association" and "GRA". One (1) record was located. The record has been examined and I have deemed it out of the scope of the FOI Act insofar as it refers to An Garda Síochána. It is not an administrative record relating to finance, human resources or procurement. The record located is shown on Schedule A (attached).

2. Right of appeal
