Request Refusal - Out of Scope

I refer to the Freedom of Information Act 2014 and your submission to this body dated 5th October 2015 and received on 19th October 2015.

Your request is shown below:

Please provide details about how many civilians have been injured and killed by An Garda Síochána vehicles in the last three years, broken down by month and area. If possible, can this figure outline what proportion of these incidents occurred during emergency responses and if there was an internal investigation in relation to the incidents.

wish to inform you that your request has been refused.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. After reviewing your request I have decided that it is not within the scope of the Freedom of Information Act 2014 insofar as An Garda Síochána is concerned and as a result no information will be provided to you on this matter.

2. Right of appeal
