## Re: Freedom of Information Request FOI-000068-2015 Request Refusal

#### Dear

I refer to the Freedom of Information Act 2014 and to your submissions to this Body, dated and received on the 19th of October 2015.

Part 1 Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included Agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

### Your request is show below:

- "1) The number of requests for the cancellation of fixed processing charges for speeding that were received since the decision-making process was centralised in the Fixed Charges processing office in Thurles in September 2014
- 2) The number of requests for the cancellation of fixed processing charges for speeding that were granted since the decision-making process was centralised in the Fixed Charges processing office in Thurles in September 2014
- 3) The number of requests for the cancellation of fixed processing charges for speeding that were declined since the decision-making process was centralised in the Fixed Charges processing office in Thurles in September 2014
- 4) The reasons given for the cancellation of each of the fixed processing charges for speeding since the decision-making process was centralised in the Fixed Charges processing office in Thurles in September 2014
- 5) Copies of any further audits carried out by Gardai Professional Standards Unit on the operation of the new system for processing appeals against fixed charges for speeding

in the Fixed Charges processing office in Thurles (excluding the audit which was published in January 2015)"

I, have now made a final decision to refuse your request on 12<sup>th</sup> November 2015

The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decisions to deny access

As An Garda Síochána is listed as a partially included Agency under the Freedom of Information Act, 2014 "insofar as it relates to administrative records relating to human resources, or finance or procurement matters" and the information you have sought refer to operational policing matters and falls outside these areas I am precluded by the Act in releasing this information.

Criminal Justice (Fixed Charge Processing System) Working Group was established following the Garda Inspectorate's review of the Fixed Charge Processing System. The function of the Criminal Justice (FCPS) Working Group is to oversee and facilitate the implementation of the recommendations of the Report on the Fixed Charge Processing System. The remit of the Working Group has been extended to include oversight of a number of the recommendations of the Garda Professional Standards Unit Examination of the Procedures, Policy and Decision Making Processes in Relation to Cancellations on the Fixed Charge Processing System of Road Traffic Related Offences. Further information on this working group and any additional reports may be available from the Department of Justice and Equality.

### 2. Right of appeal
