I refer to the Freedom of Information Act 2014 and your submission to An Garda Síochána dated and received on the 19/2/2016.

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

• I wish to request records of the number of Gardaí deployed to the University of Limerick on Monday 15th February for the RTÉ Leaders Debate, as well as the records on whether the number of Gardaí was increased later on Monday evening as the political leaders arrived at the university. I also wish to request records of where these Gardaí were deployed from (e.g. were all Gardaí present at the University from Limerick Garda Station?) and if extra Gardaí were taken on for the day to replace them. As well as this, I wish to request records of the cost to An Garda Siochana of providing these Gardaí for the RTÉ broadcast at the university

I, Helen Deely, Superintendent wish to inform you that your request is outside the scope of the Freedom of Information Act 2014 insofar as it pertains to An Garda Síochá as only administrative records that relate to human resources, finance or procurement shall be considered.
