Request Refusal

Dear

I refer to the Freedom of Information Act 2014 (FOI Act) and your submission to this body dated and received on the 26th February 2016 for records held by An Garda Síochána.

Part 1 (n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

"I request a copy of the following documents (or documents containing the following information) to be provided to me: The number of man hours Gardaí spent monitoring CCTV in Limerick city in the years 2011 to 2015".

I wish to inform you that your request has been refused.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

I am refusing your request on the basis that the records you seek do not exist. The monitoring of CCTV is not performed across Limerick City in a manner that can be calculated in "man hours". The monitoring of CCTV by Gardaí in Limerick City is not a specific duty type and could be part of other duties being performed at the same time. Therefore it is not possible to identify the time spent by Gardaí performing that function as no specific record exists. Section 15(1)(a) of the FOI Act is applicable in this situation.

Section 15(1)(a) of the FOI Act 2014 is as follows:

Refusal on administrative grounds to grant FOI requests

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where—
 - (a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,

I am refusing your request under section 15(1)(a) of the FOI Act.

2. Right of appeal
