Part 1 (n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

- 3. The number of identified innocent casualties or victims of crossfires. i.e victims not related to any gangland activity during 2015.
- I, Helen Deely, Superintendent wish to inform you that your request is outside the scope of the Act insofar as it pertains to An Garda Síochána and as a result I am refusing to provide the information you have sought in your request.
