Re: Freedom of Information Request FOI-000158-2015 Request Refusal

Dear

I refer to the Freedom of Information Act 2014 and your submission to this body dated 24th November 2015.

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

Garda agenda, reports and minutes arising from meetings of the Garda management team since 1st January 2015 in relation to the Traffic Corp.

I wish to inform you that your request has been refused.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

As stated above, An Garda Síochána is a partly included agency under Part 1 of Schedule 1 of the Freedom of Information Act, 2014 "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I have examined both the agendas and minutes for the Traffic Corp as per your request and have found no entries which relate to finance, procurement or human resources. As the contents of the records fall outside these areas, I am refusing your request as it is outside the scope of the Act.

2. Right of appeal

The making of a late appeal may be permitted in appropriate circumstances.
