I refer to your request, dated 27th April 2016 and received on the 28th April 2016 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I wish to request copies of all replies issued by An Garda Síochána in response to Parliamentary Ouestions between November 14, 2015 and April 27, 2016 (dates inclusive).

I wish to inform you that your request has been refused.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decisions to deny access

I advise that I am unable to provide you with the requested records under the Freedom of Information Act, 2014 as they are exempt records under Section 42(j) which reads as follows:

Restriction of Act.

42. This Act does not apply to –

(j) a record given by an FOI body to a member of the Government or a Minister of State for use by him or her for the purposes of any proceedings in either House of the Oireachtas or any committee of either or both of such Houses or any subcommittee of such a committee (including such proceedings in relation to questions put by members of either such House to members of the Government or Ministers of State (whether answered orally or in writing)),
