I refer to the Freedom of Information Act 2014 (FOI Act) and your submission to An Garda Síochána dated 3<sup>rd</sup> May 2016 and received on 6<sup>th</sup> May 2016

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

## 1. Findings, particulars and reasons for decision
