## Re: Freedom of Information Request FOI-000183-2015 Request Refusal

Dear

I refer to the Freedom of Information Act 2014 and your submission to this body dated 1<sup>st</sup> December 2015 and to our email of 4<sup>th</sup> December to which no response was received.

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

- "1) All emails and correspondences between the company 'GO SAFE' and An Garda Síochána relating to Purchase Orders made in the 3rd Quarter of 2014.
- 2) All contracts made between 'GO SAFE' and An Garda Síochána relating to Purchase Orders made in the 3rd Quarter of 2014."

I wish to inform you that your request has been refused.

The purpose of this letter is to explain that decision.

## 1. Findings, particulars and reasons for decision

I am refusing your request on the basis that the records referred to do not exist.

Section 15(1)(a) of the Freedom of Information Act 2014 is as follows:

15. (1) A head to whom an FOI request is made may refuse to grant the request where—

(a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken.

The Procurement Section of An Garda Síochána advise that the payments referred to in your request are for the provision of services by Go Safe under a long term contract. Therefore, there are no specific purchase orders or contracts in existence relating to the payments made in the 3<sup>rd</sup> Quarter of 2014.

In accordance with the requirements of section 15(1) (a), of the Freedom of Information Act 2014, I must therefore refuse your request on this basis.

## 2. Right of appeal
