

Dear

I refer to your request, dated 16/05/2016 and received on 16/05/2016 which you have made under the Freedom of Information Act (FOI) 1997 and 2003 for records held by An Garda Síochána. An Garda Síochána became subject to the provisions of the FOI Act 2014 on the 14th October, 2015.

Your request sought:

Under the Freedom of Information Acts 1997 and 2003 I request:

- 1. All records relating to items stolen from the gardaí for years 2013, 2014 and 2015.
- 2. Records detailing items stolen from garda cars, headquarters, garda stations etc.

Part 1(n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that your request is outside the scope of the Freedom of Information Act 2014 insofar as it pertains to An Garda Síochána, in that the records sought by you are not an administrative record relating to human resources, finance or procurement.

Right of appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number F01-000194-2016.

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
