Dear

I refer to your request under the Freedom of Information Act 2014, dated 13th March 2016 to the Department of Justice and Equality which was transferred to this body on the 17th May 2016 in which you have sought records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your initial request sought:

I request a copy of all records concerning the operation of the fixed charge notice system for driving offences and Tico Mail Works.

Which you have subsequently clarified as follows:

The difficulties I refer to would include difficulties and complications in or complaints about the service of FCP notices and the resulting difficulties which arise in prosecution of FCPS cases, along with any other difficulties in the FCPS which have arisen in court prosecutions

I advise that as your request relates to operational policing matters and not to administrative records for human resources, finance or procurement your request is out of scope as far as it pertains to An Garda Síochána.

However, I advise that the Garda Professional Standards Unit carried out a report on the Fixed Charge cancellation process which you may find useful. The report is available on the Garda Website at
