

Re: Freedom of Information Request FOI-000201-2016

Dear

I refer to your request, dated and received on 20/05/2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Your request sought:

- How many reports relating to the Public Order Act 2003 and 1994 have been made relating to incidents that have occurred on Dublin Bus, Luas, DART and Bus Eireann since January 2012 by An Garda Siochana.
- As well as how many reports relating to damage done (buses and trams) to any of the aforementioned services have been made since January 2012.
- In addition could you supply me with the dates, locations, times, and nature (section of Public Order Act cited) of the reports recorded by the Gardaí.
- The number of complaints made of anti-social behaviour by the public (including the nature
 of these complaints in relation to the Public Order 2003 and 1994 that allegedly occurred,
 their locations and dates of the incident) to An Garda Siochana should be included, as well as
 reports filed in relation to arrests by Gardaí.

Part I(n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Siochána is listed as a practically included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that your request is outside the scope of the Freedom of Information Act 2014 insofar as it pertains to An Garda Síochána, in that the records sought by you are not an admistrative record relating to human resources, finances or procurement.

Right of appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number F01-000194-2016.

The making of a late appeal may be permitted in appropriate circumstances.
