I refer to your request, dated and received on 10/06/2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

We have been researching and documenting evidence for 40 years of a new burn injury classification - the Fifth Degree Burn - that is characterized by localized and near-total incineration of the victim amid absence of significant heat/flame damage to surrounding combustibles. Such events are not, to quote one U.S. medical examiner's comment to us, "hoaxes, because bodies do not burn this way." Though rare, Fifth Degree Burn cases do happen and warrant serious study.

Two recent cases in Ireland - one of which we just learned about - are pertinent to our research:

"A garda described finding the charred remains on the floor of the sitting room with the damage just confined to the remains and the immediate vicinity," reports local press coverage.

Assistant chief fire officer and Garda and Garda are mentioned in press reports, Garda saying "the only damage was to the remains, to the floor underneath him and to the ceiling above. The body had been totally burnt."

We request the investigation reports of these two incidents, photographs (and in the case of video) of the fire scenes, and inquest hearings for the purpose of comparison to other potentially similar cases in our extensive database and. thus, to better understand these rare, fascinating, controversial fire scenes that definitely are *not* hoaxes. Ireland has a forgotten history of these events, one we are now endeavoring to reveal, and with your cooperation we'll know whether these two incidents should be included or excluded.

I wish to inform you that I have decided to refuse your request on the 13th June 2016.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decisions.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Siochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. As you are seeking records relating to operational policing matters your request is not within the scope of the FOI Act insofar as it pertains to An Garda Siochána, and therefore I cannot accede to your request.
