## Re: Freedom of Information Request FOI-000256-2016

#### Dear

I refer to your request, dated 09/07/2016 and received on 11/07/2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

#### Your request sought:

Please can you tell me how many deaths by suicide have been reported to police / or have been attended by police in the Cavan area in the last three years, including a breakdown of age and gender.

I wish to inform you that I have decided to refuse your request on the 14th July 2016.

The purpose of this letter is to explain my decision.

#### 1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which is a core function of An Garda Síochána. Records relating to the core functions of An Garda Síochána are excluded from the ambit of the FOI Act.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

However, the information you seek may be available from your local Coroner's Office. The contact details of which are available on the Coroner's website, which can be accessed by following the attached link: www.coroners.ie.

### 2. Right of Appeal
