I refer to your request, dated 29th September, 2016 and received on 30th September, 2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I am seeking some information on a disturbance that may have occurred in Ballyhaunis, Co. Mayo in August/September of last year.

I do freelance research for various journalists. I am not seeking information on operational matters, nor am I interested in Garda actions on the day.

My understanding of the alleged event in question - from speaking to witnesses - is as follows:

Ag obair le Pobail chun iad a chosaint agus chun freastal orthu / Working with Communities to Protect and Serve

A film crew led by a well-known TV presenter was preparing a two part documentary for RTE and sought to film a religious site in Ballyhaunis, Co. Mayo. Several worshipers became aggressive and territorial, and tried to prevent filming. A standoff ensued and Gardaí were called. No reference was made to such an event in the documentary that aired on RTE.

RTE is a public service broadcaster. Releasing a Garda synopsis of any such occurrence or other relevant information pertaining to the alleged event would be in the public interest, if indeed, it was suppressed by RTE.

I wish to inform you that I have decided to refuse your request on the 11th October, 2016.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

2. Right of Appeal

The making of a late appeal may be permitted in appropriate circumstances.
