Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered

### Your request sought:

- The highest speed clocked by speed cameras and where?
- The number of images taken by ANPR cameras.
- Number of people in Dublin caught in 2016 using mobile phones while driving.
- When are speed cameras turned off if ever?
- Number of people fined in Dublin for riding a bike on the pavement in 2016.
- · Physical attacks on speed cameras in 2016.
- Top 10 streets in Dublin with the most accidents.
- Bus lane fines on drivers in Dublin.
- What are the speed camera detection rates?
- Number of people fined in Dublin for breaking a red light on a bike in 2016.

I wish to inform you that I have decided to refuse your request on the 19th October,2016.

The purpose of this letter is to explain my decision.

# 1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

However, I advise that this information may be made available to you outside of Freedom of Information by submitting a media request to the Garda Press Office at Garda Headquarters, Phoenix Park, Dublin 8, D08 HN3X or emailing <a href="mailto:pressoffice@garda.ie">pressoffice@garda.ie</a>.

I also advise that the responsibility for the administration of penalty points is a matter for the Road Safety Authority (RSA).
