The number of times gardaí have been called to Crumlin Children's Hospital in Dublin in response to reports of theft between July 2015 and November 2016

The number of times gardaí have been called to Temple Street Children's Hospital in Dublin in response to reports of theft between July 2015 and November 2016

Specific details regarding these callouts, where possible

I wish to inform you that I have decided to <u>refuse</u> your request on the 23rd November, 2016.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is seeking information pertaining to operational Garda matters that took place at the premises listed above. A record of operational activities by members of An Garda Síochána is not considered an <u>administrative</u> record and does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.
