#### Re: Freedom of Information Request FOI-000010-2016 **Partial Grant**

Dear

I refer to the Freedom of Information Act 2014 and my correspondence to you of 12th January 2016 and to your submissions to this body, dated and received on 12<sup>th</sup> January 2016.

I refer to the request which you made under the Freedom of Information Act 2014 for records held by An Garda Síochána:

'I wish to request a record of staffing levels of An Garda Síochána at station (sub-district) level for December 31, 2014 and December 31, 2015 (ideally in spreadsheet format).'

I have now made a final decision to part grant your request.

The purpose of this letter is to explain that decision.

#### 1. Findings, particulars and reasons for decisions to deny access

Your request is being refused under section 32(1)(a)(i) and 32(1)(a)(ii) of the Freedom of Information Act 2014 as I am of the opinion that this information can be reasonably expected, if used inappropriately, to prejudice or impair the Garda Organisation operational capabilities in:

- "the prevention, detection or investigation of offences, the apprehension or (i) prosecution of offenders or the effectiveness of lawful methods, systems, plans or procedures employed for the purposes of the matter aforesaid"
- "the enforcement of, compliance with or administration of any law" (ii)

The detail sought by you in your request seeks to identify, in detail, the operational capabilities of An Garda Síochána on a station (sub-district) level. This type of information is not provided due to its operational sensitivity. This information, if made available, could reasonably be expected to pose a risk to the safety of local Gardaí when endeavoring to enforce legislation and keep the public peace in the future. If the number of Gardaí were provided on a station (sub-district) level, it is reasonable to believe that a criminal organisation could use this information to assess the capabilities of the local Gardaí to deal with certain types of crimes, thus prejudicing the Garda Organisation's effectiveness in enforcing legislation. The duty roster system in use in An Garda Síochána is available in the public domain and cross referencing that system with the number of Gardaí on a station (sub-district) basis, could allow for a prediction to be made as to the response capabilities of Gardaí by a criminal organisation. This is an unnecessary risk to the law enforcement procedures employed in stations (sub-districts) and the staff of same.

However, I am in a position to provide you with the number of Gardaí by rank from Garda to Chief Superintendent inclusive within each Division. Please see Appendix A & B attached.

Appendix A outlines Garda resources as of 31<sup>st</sup> December 2014 and Appendix B as of 31<sup>st</sup> December 2015.

There are a number of vacancies at the various ranks and a number of competitions are currently underway to fill these.

#### 2. Right of appeal
