I refer to the Freedom of Information Act 2014 and my correspondence to you of 15th October 2015 and to your submissions to this body, received on 15th October 2015.

I refer to the request which you made under the Freedom of Information Act 2014 for records held by An Garda Síochána:

How many members of An Garda Siochana or staff have been dismissed from their position since 2004 - 2015 to date?

Why were they dismissed?

How many members of An Garda Siochana or staff have been demoted in the same time frame? Why?

How many members of An Garda Siochana or staff have there been disciplined or reprimanded for sexual harassment in the workplace in the same time frame?

What was the nature of these complaints, what was the outcome?

How many members of An Garda Siochana or staff have failed drug tests in the same time frame? What was the outcome of the failed test?

What drugs were detected?

wish to inform you that your request has been part granted.

## 1. Findings, particulars and reasons for decisions

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

As An Garda Síochána was not an included body prior to the commencement of the Freedom of Information Act, 2014, we can only provide information from 21<sup>st</sup> April 2008. Therefore the information you sought from 2004 to 21<sup>st</sup> April 2008 cannot be provided to you.

In part-granting your request, I am applying Section 15(1)(d) wherein it states:

A head to whom an FOI request is made may refuse to grant the request where – (d) the information is already in the public domain

The information sought in respect of dismissals of members of An Garda Síochána and the reasons for same are available in the Internal Affairs Section of the Annual Reports on our website, www.garda.ie.

However, the table below outlines the number of civilian staff who have been dismissed from their positions since 21<sup>st</sup> April 2008:
